



Misconception - a view or opinion that is incorrect based on a misunderstanding of the facts.

#### Misconception no. 1:

#### The UK's population only became multicultural in the 1900s.



#### Settlement of Black Roman soldiers, 3<sup>rd</sup> century CE.

#### **Misconception no. 2:**

#### If there were Black people living in Britain before the 1900s, they would have been enslaved.



#### The Ivory Bangle Lady

She was a high-status adult female, of North African descent, who died in York in the 4th century CE. Her skeleton was found with bracelets, pendants, earrings, beads as well as a glass jug and mirror.

#### **Misconception no. 3:**

## Europe has always been richer and more 'advanced' than Africa.



#### Mansa Musa, 1280 - 1337 CE.

Mansa Musa, was the tenth ruler of the Mali Empire, an Islamic West African state. Historians estimate that Mansa Musa, in modern currency, was worth around \$400bn. That is more than twice as wealthy as Amazon's Jeff Bezos - the richest person alive today. Most of Mansa Musa's wealth came from gold and salt.
